libraries. Sen. Pressler defined "entities providing not-for-profit bibliographic services" as library services provided by public, academic, school, and medical libraries and cooperative library networks as defined by several federal statutes.

Although the Senate did not get a chance to consider the amendment, it services to focus congressional attention on library uses of telecommunications and the increased costs libraries face from access charges and pending tariffs. Sen. Pressler intends to pursue the issue on another vehicle, if possible.


Griffin has also served as president of the Xavier University Chapter of the American Association of University Professors and as president of the Greater Cincinnati Library Consortium.


Sharp received her bachelor's degree from Michigan State University and her MLS from the University of South Florida.

ANSS Members— Who They Are and Where They're Going

ACRL's Anthropology and Sociology Section recently conducted a survey of its members. The questionnaire was designed to determine the educational background of section members, a composite of members' responsibilities, and guidelines for future directions that the section might take. Out of the 142 respondents, 94% have library science degrees, while 58% have additional higher degrees (master's or Ph.D.), largely in social science disciplines. Professional responsibilities for most members include reference, online searching, bibliographic instruction, collection development, and faculty liaison work.

The membership indicated several directions they wish the section to take. Publications about anthropology and sociology literature ranked highest, along with the development of programs at ALA meetings. Contact with publishers of various reference tools was also deemed important.

The results of the survey were reported to the ANSS Executive Committee at their Midwinter meeting. It was noted that the current efforts of section committees are very much in keeping with the priorities expressed by ANSS members.—Patricia Ward Silvernail, Chair, Anthropology and Sociology Section.
