Compulsory Registration.

I am interested in the question of compulsory registration. During the war years all members of the Chartered Society of Physiotherapy, London, were asked to become registered members of the Board of Registration of Medical Auxilliaries.

Only about 59% of the members of the Chartered Society became enrolled on the Board's register.

However, after careful consideration and in view of the opinions expressed by members of the Council and the Society's Branches, the Chartered Society resigned from the Board, and asked all its members who had registered thereon to withdraw their names.

The Chartered Society was moved to take this action in the best interests of its members, and the Council requested the Board to remove the name of the Chartered Society and its qualifications from the Board's list of Recognised Qualifying Bodies.

I trust that our members of the South African Society of Physiotherapy will give this matter their earnest deliberation as I feel that if we become in any way affiliated to a national register we may find ourselves affiliated to a Body or Bodies, overwhich we have no jurisdiction or control. We might, for instance, be obliged to shorten the course of training, which would be a retrogressive step.

There is no way of assuring that patients will be more impressed by one form of registration than another.

We have been at pains to build up a strict code of ethics. and I feel that a compulsory national register will, in no way, safeguard our Society or any of its members.

We look to each individual member to keep up the traditions of the Society: in this way we hope to further the campaign in assisting the general public to recognise the difference between fully qualified physiotherapists and those who have not the qualifications to become registered members of the South African Society of Physiotherapy.

We are justly proud of our society, and I am sure that the present form of registration adequately meets our requirements.

Does it do the female Physiotherapist and the Physiotherapy profession any good when the male Physiotherapist is unable to mix financially with members of other branches of the Civil Service with a similar educational background?

I have been a Branch Chairman, a Regional Board Representative and a Representative to the World Confederation for Physiotherapy for the Chartered Society and I have heard only two of my female colleagues actually against increases for males, all the rest have been whole-heartedly in favour of improving the status of the male Physiotherapist.

Finally, regarding the case of the widowed Physiotherapist with a small family to support. Has this case been honestly presented? In most modern countries today a widow of this class is usually in receipt of a widow's pension and children' allowances.


